President Edgar Lungu has announced the relaxation of some measures that were announced two months ago that were aimed at stopping the spread of Covid-19.

In his national address, President Lungu announced the reopening of Gyms and Cinemas saying it is time Zambians learnt to live with the new normal.

And President Lungu has also reopened restaurants and casinos whilst ordering that pupils in examination classes should return to school.

He said the reopened businesses have a responsibility to enhance hygiene facilities at their premises.

Meanwhile, the Head of State has directed the reopening of primary and secondary schools by June 1, 2020 but ensure that all hygiene standards are in place to ensure safety of students in the context of the "new normal". (Lusaka Times)

#### A SUMMARY OF WORLD BANK RECENT REVIEW ON MINING SECTOR IN ZAMBIA

A recent review of mining sector governance and Investment attractiveness shows the country remains an appealing for Investment due to its favourable geology; long history of mining; political stability; low risk of expropriation; high levels of security and relevant favourable economic environment.

However, the same review also reviewed bottlenecks are constraining the mining sector's growth potential in Zambia. Priority areas for improvement include stability of its mining and fiscal policy; the development domestic procurement policies; improved budget transparency; and flame work for improved infrastructure development, particularly energy infrastructure.

Integrating the mining sector into national development planning is a crucial drive for sustainable development in Zambia.

Increased openness and transparency is another priority issue that government, civil society, and industry agree on. More specifically, stakeholders agreed on a perceived lack of independence of the licensing authorities. On this front, the Zambian government is making progress through an updated Mines and Minerals Act (2015) and implementation of the Extractive Industries Transparency Initiative (EITI), which they began implementing in 2009 and advanced to compliant status in 2012.
