#### MINING FOR ZAMBIA (GOOGLE SEARCH)

Mining companies in Zambia are focused on extracting the country's vast copper and uranium deposits, as well as the more limited gold, nickel and industrial deposits. It is important for mining companies in Zambia to be cognizant of and understand the primary law governing the Zambian mining sector – the Mines and Minerals Development Act no. 11 of 2015 (MMDA). This act, however, must be read together with the Mines and Minerals Development Act No. 14. Together they deal with mining rights, mining licences, large-scale mining, gemstone mining, health and safety, environmental protection and geological services on analysis.

**5S** is a workplace organization method that uses a list of five Japanese words: seiri, seiton, seisō, seiketsu, and shitsuke. These have been translated as "sort", "set in order", "shine", "standardize" and "sustain". The list describes how to organize a work space for efficiency and effectiveness by identifying and storing the items used, maintaining the area and items, and sustaining the new order.
